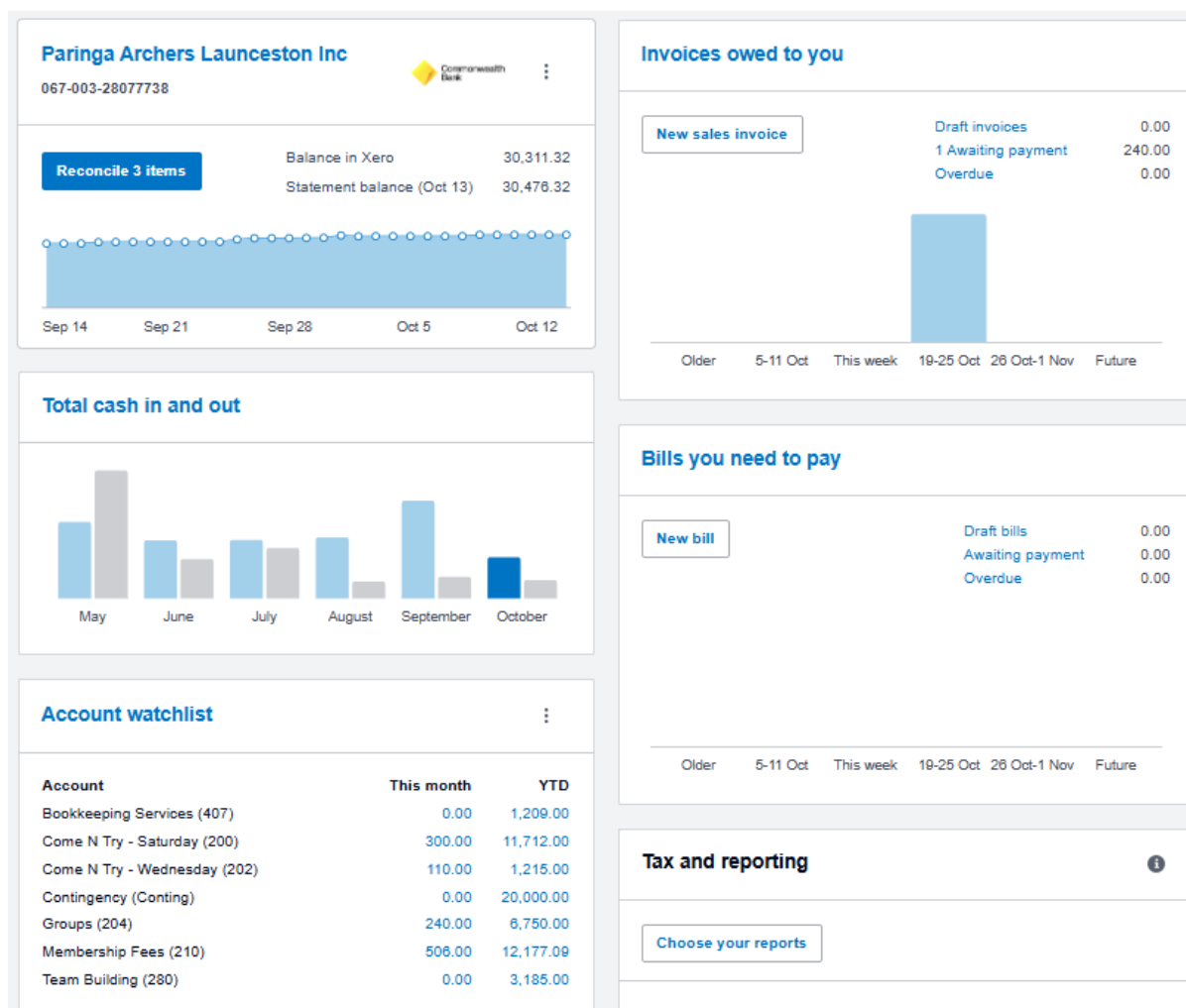
**GENERAL BUSINESS:**
